3. TARIFF FORMAT

3.1. SHEET NUMBERING

3.1.1. Sheet numbers appear in the upper left corner of the sheet. The Table of Contents sheets are numbered sequentially beginning with TC-1. All other sheets are number sequentially beginning with 1 in each new Section. When a new sheet is added between sheets already in effect, a decimal is added. For example, a new sheet added between sheet 5 and 6 would be 5.1.

3.2. SHEET REVISIONS

3.2.1. Sheet revisions appear in the upper left corner of the sheet and are used to determine the most current sheet version on file with the Arkansas Public Service Commission. For example, the 3rd Revised Sheet No. 16.

3.3. PARAGRAPH NUMBERING SEQUENCE
