

- 1.2.13. Non-listed service is an arrangement whereby a customer's number is omitted from the telephone directory but not from the information records.
- 1.2.14. When non-published or non-listed service is to be furnished, the customer may be required to execute an agreement which holds the Company harmless from any damages which might arise and which absolves the Company from any responsibility for the failure of the customer to receive calls because of the non-published or non-listed arrangement.

2. DIRECTORY ASSISTANCE SERVICE

2.1. GENERAL

- 2.1.1. The Company furnishes Directory Assistance Service whereby customers may request assistance in determining directory information in the same local calling area or in the same Long Distance Numbering Plan Area.
- 2.1.2. A customer request for directory assistance is any call to a directory assistance attendant.
- 2.1.3. A maximum of two telephone numbers may be requested per call to a directory assistance attendant.
- 2.1.4. Charges for Directory Assistance Service are not applicable to calls placed from customers whose physical, visual, mental or reading handicaps prevent them from using the telephone directory. The method of exempting those handicapped customers shall be via the completion of an exemption form supplied by the Company and the Company's acceptance of that form.
- 2.1.5. Charges for Directory Assistance Service are not applicable to calls placed from a hospital which has as its principal undertaking the inpatient medical or surgical care of the sick or disabled persons.

2.2. RATES

3.2. LINE STATUS VERIFICATION

- 3.2.1. The provision of Line Status Verification involves an operator determining the condition of an access line that a customer requests to be checked.

Dial Calling Card Station-to-Station service also includes: (1) when an operator records the calling card or Special Billing Number where no automatic recording equipment is available, (2) when an operator reaches the called telephone number and records the calling card or Special Billing Number where facilities are not available for dial completion, (3) when an operator places a calling card or Special Billing Number call for a calling party who identifies himself as being handicapped and unable to

Operator Station-to-Station is that Station-to-Station service other than Dial Station-to-Station and Dial Calling Card Station-to-Station. Operator Station-to-Station includes Station-to-Station service originating at a public or semi-public telephone, where offered, except for those public or semi-public telephone calls that are Dial Calling Card Station-to-Station as described above.

3.4.2.C. Person-to-Person

Person-to-Person is that service where the person originating the call specifies to the operator a particular person to be reached, or a particular station, department, or office to be reached through a PBX attendant.

4. OFF-PREMISES EXTENSIONS

4.1. INTRAEXCHANGE (LOCAL CALLS)

4.1.1. General

- 4.1.1.A. Intraexchange or local channel charges apply in the provision of off-premises extensions, local private line, lease line, tie line, radio broadcast circuits, and all other services, where leased channels are provided. Mileage applications may be applicable to local channels and will be measured on an airline basis unless otherwise indicated.
- 4.1.1.B. A Local Loop Charge is applicable for all private line services whereby the use of a cable pair and central office equipment are required to provide such private line services. The Local Loop Charge pertains to that portion of the loop extending up to ½ mile from the central office. 

12.3.2. After acceptance of a customer by the Company as a participant in the Extended Due Date Plan, the customer shall supply to the Company the date on which his monthly income is received (check receipt date) and the Company will make this information a permanent part of the customer's record.

12.4. SETTING THE EXTENDED DUE DATE

12.4.1. The Company will compare the check receipt date supplied by the customer with the billing date and the bill due date.

Based on this comparison, the following method of determining a bill due date will be used:

- 12.4.1.A. If the check receipt date occurs within the time span between the billing date and the bill due date, the normal due date of the account remains in effect.
- 12.4.1.B. If the check receipt date occurs beyond the time span of the billing date and the bill due date, the due date will be at least three days after the check receipt date.
- 12.4.2. If the customer does not pay bills by the close of business on the extended due date 2 times in a row or any 3 times in the last 12 months, the Company will remove the customer from the plan. The Company will notify the customer in writing when the customer has been removed from the plan for late payment.
- 12.4.3. If payments are not received by the close of business on the extended due date, the Company will follow the established notification process established by the Arkansas Public Service Commission which could ultimately result in suspension of the service.

LATE PAYMENT

13.1. A utility may calculate late payment charges only on an overdue portion of a bill for utility service. A late payment charge may not exceed 10 percent of the first 30 dollars of the customer's bill and 2 percent of the remainder. The due date of the bill shall not be less than 22 calendar after the date the bill is mailed.

14. VACATION RATE

14.1. A rate of one-half the regular monthly rate will be charged for a minimum period of one month upon advance notice by the customer.

15. FIRE ALARM SYSTEMS

- 15.1. 10 Party Installation Charge plus \$15.00 per month.
- 15.2. 14 Party Installation Charge plus \$20.00 per month.
- 15.3. 18 Party Installation Charge plus \$25.00 per month.

16. INDIVIDUAL CASE BASIS ARRANGEMENTS

16.1 GENERAL

- 16.1.1. Individual Case Basis Arrangements ("ICB") are service arrangements provided by the Company in which the regulation, rates and charges are developed based on the specific circumstances of the case.
- 16.1.2. ICB arrangements will offer specialized rates or charges only for nontariffed services and/or rate elements. Notwithstanding the language in this paragraph 16.1.2., DS-3 circuits (45 megabits) may be priced to cover no less than their incremental cost up to rate levels covering such service in approved tariffs for education institutions.
- 16.1.3. ICB arrangements will be offered at such rates and charges that

shall, in the aggregate, cover no less than their incremental cost.

16.1.4. Such rates and charges are subject to review by the Arkansas Public Service Commission at any time upon request.

16.2. CONDITIONS

- 16.2.1. ICB arrangements will initially be restricted to service offerings to educational institutions or governmental bodies, divisions or institutions.
- 16.2.2. Customers will be required to sign a contract with the Company specifying the terms and conditions of the service arrangement.
- 16.2.3. The Company will notify the Public Service Commission in writing before a sixth ICB service arrangement is entered into. The notice will include a description of the service or rate element affected and a projected number of total customers for the specialized rate or charge. The Commission may or may not require the filing of a tariff relative to the specific rates or charges at that time.
