## FOREIGN EXCHANGE SERVICE

## 1. **GENERAL**

- 1.1. Foreign exchange service is exchange service furnished to a customer from an exchange other than the one that normally serves the area in which the customer is located.
- 1.2. The rates and regulations herein stated shall apply to all existing services of this type, whether previously existing, or not, unless these rates and regulations are subsequently modified by Commission action.
- 1.3. For the purpose of this tariff the term, "Foreign Exchange," shall mean the exchange from which foreign exchange service is furnished. The term "Normal Exchange," shall mean the exchange normally serving the area in which the customer's premises are located.
- 1.4. Foreign exchange service does not come within the Company's general undertaking, nor does the Company obligate itself to furnish such service generally; but will do so at its option where facilities of such a character are available as will permit satisfactory telephone transmission, and where the service is warranted by the circumstances involved.
- 1.5. Foreign exchange service will be provided only in connection with private branch exchange trunk lines, and individual line business or residence service. The service will be limited to one location or premises and may not be extended to other locations by means of outside or off premises extensions.
- 1.6. Where the normal exchange is operated by the Company, foreign exchange service is furnished only on the condition that the applicant is a customer to individual line business or residence service in the normal exchange and at the same location where such service is proposed to be installed.
