I. GENERAL

- 1.1 Custom Calling Services are optional telephone service arrangements which provide one or more of the following features:
 - 1.1.1 Call Waiting Alerts a customer who is using his telephone that another caller is trying to reach him.
 - 1.1.2 Call Forwarding Permits a customer to transfer all incoming calls to another telephone number within the exchange or on the Long Distance Telecommunications Network where facilities permit. The Call Forwarding customer is responsible for the payment of charges for each call between his Call Forwarding equipped telephone and the telephone to which the call is being forwarded. The transmission may vary depending on the distance and routing necessary; therefore, transmission may not meet normal standards.
 - 1.1.3 Three Way Calling Enables a customer to add a third party to an existing call without operator assistance, thereby, establishing a three-way conversation. The transmission may vary depending on the distance and routing necessary; therefore, transmission may not meet normal standards.
- (AD) 1.1.4 Three Way Calling with Universal Transfer enables a customer to add a third party to an existing call and then drop off of the call without interrupting or disconnecting the other two parties. After transferring a call to the third party, your line will be free to receive or make another call.
- (CT) 1.1.5 Speed Calling Enables a customer to place calls to other telephone numbers by dialing a one digit code rather than the complete telephone number.
- (CT) 1.1.6 Distinctive Ringing Allows a customer to add another telephone number to their existing line which when called rings differently than their existing main line,
- (CT) 1.1.7 Remote Call Forwarding A telephone number that forwards to another telephone number. A charge in either number must be done by the

2.2. Moves and Changes

- 2.2.1. The Installation Charge will apply when changing from the 8 Code capacity to the 30 Code capacity, or vice versa.
- 2.2.2. The Installation Charge will apply when the customer's telephone number is changed for his convenience.
